3	2.1	9	Kring Point State Park not listed on this page. Is Kring Included?	Kring Point is included in the scope of service. Please see the attached Amendment 1.
4	2.2.1	9	"Hazing will be conducted an average of 10 times per week." Is that 10 times per Service Area?	Number of visits are an average for each service area and used only for planing purposes. Per IFB Section 2.2.1 "Individual service areas may be required to be visited more than 10 times per week as necessary, as determined upon discussion between Contractor and onsite OPRHP representative."
5	2.2.1	9	"At no time during this period will the total number of hours in any twice monthly invoicing period exceed 155 hours." Is that 155 hours per Service Area?	The number of hours refers to hours per invoice period for all locations combined.
6	2.2.3	10	In previous years, hazing has continued until a Service Area closed for the season, in some areas that was through the end of September. Has that changed?	Service is to conclude September 1 of each year, unless directed by an OPRHP representitive that the service needs to continue. Please see the attached Amendment 1 for more information.
7	2.2.1 2.2.2 2.2.3	9 & 10	Are increased visits <u>in addition</u> to the Estimated Hours on Attachment 1 – Financial Proposal or <u>included in</u> the Estimated Hours?	Estimated hours included on Attachment 1 - Financial Proposal represent OPRHP's best estimate and guarantee no minimum or maximum amount of work. These hours are an estimate for the full term of the contract.
