Notice of Intent to Prepare a Draft Generic Environmental Impact Statement

This notice is issued pursuant to Part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) of the Environmental Conservation Law. The NYS Office of Parks, Recreation and Historic Preservation (OPRHP) as Lead Agency has determined that the action described in this notice may have a significant adverse impact on the environment, and that a Draft Generic Environmental Impact Statement (DGEIS) will be prepared.

Title of Action: **Adoption and Implementation of the State Historic Preservation Plan/Generic Environmental Impact Statement (GEIS) 2021-25**

SEQR Status: Type I Action under 6NYCRR Part 617, of the implementing regulations pertaining to Article 8 (State Environmental Quality Review) of the Environmental Conservation Law.

Location of Action: Statewide

Description of Action:

The New York State Office of Parks, Recreation & Historic Preservation Division for Historic Preservation is preparing a Statewide Historic Preservation Plan/GEIS that provides direction for preservation efforts throughout the state. Through the planning process, New York engages the public in assessing the state's preservation progress, needs, and opportunities. It also offers a vehicle for furthering the integration of its historic and cultural resources into local planning and community development while instilling civic pride in New York's past. The plan guides preservation efforts at the local, regional and state levels. It serves as a blueprint for identifying and preserving New York's historic and cultural resources and is periodically updated to address current needs, issues, and opportunities. The plan details resources that have the potential to support preservation and community development efforts. The plan aims to further preservation activities by outlining a broad set of goals and objectives combined with specific strategies.

Development of a 5-year State Historic Preservation Plan is a requirement by the National Park Service for continued receipt of federal Historic Preservation Fund grant monies.

Reasons Supporting this Determination:

OPRHP considers adoption and implementation of this statewide plan to be an action which may have significant impacts on the environment because it provides direction and guidance for preservation on local, regional and state levels and may affect future management and development decisions across the state for historic and cultural resources. New York State contains significant natural, cultural and scenic resources. This plan is focused on the state's historic and cultural resources and has the potential for impacts to these resources.

OPRHP has compared the issues and impacts with the significance criteria listed in Part 617.7. The GEIS process will allow OPRHP to evaluate alternatives by assessing potential impacts to these resources and select the best plan for direction of historic preservation in the state.

Scoping:

Scoping of the DGEIS will be conducted. OPRHP has prepared a Draft Scoping Document. The Draft Scoping Document is available on the internet for viewing or downloading at: <https://parks.ny.gov/inside-our-agency/master-plans.aspx>.
