HOW TO MAKE A COMPLAINT AGAINST THE STATE PARK POLICE

HOW TO MAKE A COMPLAINT

If you wish to make a complaint about the actions of an employee of the NYS Park Police, or about any aspect of police operations, you may do so in any of these ways:

- Come to a State Park Police Station and tell any police employee that you want to make a complaint;
or
- Call a State Park Police Station and tell the person answering the phone that you want to make a complaint;
or
- Complete the “*New York State Park Police Public Compliment or Complaint Form*”, located on the agency website:

or

- Write your complaint and mail it to:

**Commanding Officer, New York State Park Police
Zone Headquarters**

Any member of the department will assist you in filling out a report of complaint against Police personnel or the State Park Police. The officer will ask you to identify yourself and then to give specific details about your complaint.

Your complaint will then be investigated. You may be contacted and asked additional questions about your complaint.

If the investigation reveals any wrongdoing on the part of the member(s) of the New York State Park Police, the appropriate action will be taken.
