## Marina Policies and Procedures

The following policies and procedures are in effect to ensure that your stay is safe and enjoyable.

**QUIET HOURS ARE OBSERVED FROM 10:00 p.m. to 7:00 a.m.** Only registered boaters are allowed in the marina during these hours. Strict enforcement of this policy will contribute to peace and quiet for all boaters. Radios and music should not disturb your neighbors at any time.

Check-out time is 11:00 a.m. for transient slips. Please re-register or checkout by that time. Fourteen days is the maximum stay allowed in a transient slip from the 4<sup>th</sup> Saturday in June until Labor Day.

The availability of water may be limited before Memorial Day and after Columbus Day.

Boaters are not allowed to assign, sublet or transfer slips, directly or indirectly. Overnight occupancy of camping units is not allowed in the marina.

Please keep your slip neat and orderly. Runways and boardwalks should be kept clean at all times. Rowboats, dinghies and other accessory equipment must be kept within the confines of the assigned slip.

Docking of Jet skis and other small craft that have unique vessel identification numbers, require separate slip agreements, and separate slip assignments.

Carpeting, tires, firehoses, TV antennas etc. are not to be attached to the piers, catwalks or piles. Painting, stripping of paint, hanging clothes and laundry are not permitted. Heads (toilets) shall be dumped in the designated on-shore dumping stations only. All accessory items and personal belongings must be removed from marina at end of slip agreement period, failure to do so could jeopardize future slip assignment.

Open fires are not allowed in the marina. Any conditions aboard or around a boat that shall be deemed a fire hazard, in the opinion of the park manager, shall be removed immediately.

All applicable park, state and federal rules and regulations will be observed. The park manager reserves the right to terminate any permit, when necessary, in order to ensure the peace, comfort and safety of boaters.

Fishing is not allowed in the marina basin.

Pets must be kept under constant control and restrained by a leash not exceeding six feet in length. Proof of rabies inoculation is required in the form of a veterinary certificate. Maximum of two pets per slip.

Restroom key cards are issued to Seasonal Wet Slip holders and must be returned to the Marina office at the end of each season.

### **All boats must be removed from the marina by October 15<sup>th</sup>.**
