

## Max V. Shaul State Park Pavilion Information




Reservation Fee: \$75.00/day (+ \$7.25 Reserve America Fee)

## **Important Information**

- The pavilion at Max V. Shaul State Park may be reserved any day during the camping season, which generally runs the weekend before Memorial Day to Columbus Day.
- Starting January 1, 2020, reservations for all available days are made on a first-come, first-serve basis. Availability can be checked online at www.reserveamerica.com or by calling the park office at (518) 827-4711. Reservations can be made by calling the park office.
- You MUST call the park office to reserve the pavilion. Paper applications are no longer being used, nor will they be accepted.
- All pavilion rentals must be finished and vacated by 9 PM.
- If you are going to have alcoholic beverages, you must obtain an Alcohol Beverage Permit at the park office on the day
  of the event, pending compliance of all NYS Laws and Park Rules and Regulations governing the consumption of
  alcoholic beverages.
- Please understand that on the day of your reservation, the park may be holding an event. If an event is going on near the pavilion or tent, the park office will let you know ahead of time so you may plan accordingly.

- Any picnic tables, grills, playground equipment, or parking spaces in surrounding areas that are not being used by your group may be used by other park patrons. All restrooms are for general public use.
- This is a **CARRY IN/CARRY OUT** facility. There are no trash receptacles provided at the pavilion or throughout the park. It is your responsibility to make sure that the area is cleaned before leaving. Properly sorted garbage and recycling may be disposed of in the garbage receptacles located by the front entrance as you leave.
- All vehicles must park in designated parking areas.
- All pets must be kept on 6' maximum leash and have proof of rabies vaccination.
- Special Use Permits are required for activities involving catering services, wedding ceremonies, DJs or live bands, bounce houses, or tents greater than 10' by 10'. Additional fees may apply and all contracted parties must provide a certificate of insurance naming State Parks as additional insured. Please contact the park at least 30 days in advance to obtain necessary permits. Failure to do so may result in a cancelled rental.
- ALL fireworks, sparklers, and sparkling devices are strictly prohibited from use in all New York State Parks.
- Any disorderly conduct, violation of rules and regulations, or refusal to comply with park officials' directives may result in your group being asked to leave the park, and/or police intervention (including but not limited to ticket/arrest).
