**APPLICATIONS BEING ACCEPTED FOR AVAILABLE PUBLIC USE OF  
TWO ARTIFICIAL TURF FIELDS  
AT BRENTWOOD STATE PARK FOR THE FALL SEASON**  
*(First-Come, First-Served Basis)*

(Babylon, New York, September 16, 2013...) The New York Office of Parks, Recreation, and Historic Preservation is pleased to announce that beginning September 16, 2013, the Long Island State Park Region will be accepting applications, on a first -come first -served basis, for available evening time slots for the artificial turf Fields #1 and #2 at Brentwood State Park.

Anyone interested in securing field usage for the fall season must complete a park use application and either mail, or hand deliver, the application to: Long Island State Park Headquarters, 625 Belmont Avenue, Babylon, NY 11702. Park Use applications can be downloaded under the Long Island Region at [www.nysparks.com](http://www.nysparks.com).

Field #1 is a lighted, multiuse, artificial turf, full-size field. It is lined for both soccer and lacrosse.

Field #1 availability and fees are as follows:

- Mondays, September 16 through November 11  
4:00pm-6:00pm; 6:00pm-8:00pm; 8:00pm-10:00pm
- Saturdays, September 21 through November 16  
6:00pm-8:00pm; 8:00pm-10:00pm
- The fee, per two hour time slot, is \$200 plus an additional \$50 an hour for the use of lights

Field #2 is an artificial turf, full-size field, lined for soccer only. Portable lights will be used to illuminate this field. This field can be used for practices only. Field #2 availability and fees are as follows:

- Mondays, September 16 through November 11, 8:00pm-10:00pm
- Tuesdays, September 17 through November 12 8:00pm-10:00pm
- Wednesdays, September 18 through November 13 8:00pm-10:00pm
- Thursdays, September 19 through November 14 8:00pm-10:00pm
- Fridays, September 20 through November 15 8:00pm-10:00pm
- Saturdays, September 21 through November 16 8:00pm-10:00pm
- Sundays, September 22 through November 17 8:00pm-10:00pm
- The fee, per two hour time slot, is \$200 plus an additional \$50 an hour for use of lights
