

2026 MARTHA WASHINGTON WOMAN OF HISTORY AWARD

Each year, in honor of our original first lady, Washington's Headquarters State Historic Site presents the "Martha Washington Woman of History Award." The award recipient must be a woman who has demonstrated a contribution towards the education and preservation of history in the Hudson Valley. The recipient will receive her award at "The General's Lady," a Women's History Month program held each year in March. The recipient's name will receive a place of honor on the plaque showing past recipients of this award, and she will be invited to be part of the selection committee for future awardees.

Washington's Headquarters State Historic Site opened in 1850, making it the first publicly-owned historic site in the nation. The Commander-in-Chief, Gen. George Washington, established headquarters at Jonathan and Tryntje Hasbrouck's farmhouse from April 1, 1782 until August 19, 1783. This became the longest of his stays at any one of his over 65 headquarters during the 8½ years of the Revolution.

While here, the general, his wife, officers, and free and enslaved servants lived and worked in close quarters as guests came to meet with the Washingtons. During his time in Newburgh, Washington negotiated with a contentious congress while dealing with problems of supply, training, pay, morale and all other things that affected his troops. It was here that he rejected a suggestion of an American monarchy, defused a potential army mutiny, created the Badge of Military Merit, the forerunner of the Purple Heart medal, and offered advice on the future of the new republic later included in the constitution. On April 19, 1783, Washington's order for a "cessation of hostilities" was announced and he then dealt with the disbandment of the army.

An essential part of this equation was the presence of Martha Washington. Each winter during the war, Martha would travel to be with her husband. In Newburgh, Martha Washington relieved several responsibilities from the shoulders of her husband. She helped the aides-de-camp copy letters and orders, became the headquarters' hostess to the dignitaries and individuals looking to meet the general, embroidered her dining room chair covers for Mount Vernon, and maintained a garden.

ELIGIBILITY and CRITERIA

Any woman who has made a significant contribution to the field of Hudson Valley history through education, promotion, or preservation is eligible to be nominated for this award. She can be someone who was involved in a project dealing with history and/or historic preservation. This individual must have been influential in promoting the study of Hudson Valley history even at its most basic or grassroots level.

All of this should be elaborated upon by way of example in the nomination form. Additional supportive material is encouraged. Linked webpages will <u>not</u> be accessible to the selection committee. The deadline for receipt of applications is **January 16**, **2026**. Nominations will be reviewed by the selection committee made up of Washington's Headquarters staff and previous Woman of History Award recipients. The winner will be announced in early March and the award will be presented at "**The General's Lady" on Sunday, March 22nd.** For more information please call 845-562-1195 or email <u>whqshs@parks.ny.gov</u>.
