The Proposed Action is the development of the core elements or trail components of the Hudson Highlands Fjord Trail, including 7.5 miles of Main Trail and 6.5 miles of Trail Meanders, and would include Trail Banks, Water Trail Connections, and Regional Trail connections. This consistency review covers Fjord Trail North, which is the five-mile northern portion of the proposed Fjord Trail from the City of Beacon south to the northern end of the Breakneck Connector and Bridge Project approximately at Breakneck Ridge. Fjord Trail North would connect to a number of existing recreational resources including Long Dock Park, the Klara Sauer Trail, Denning's Point, Madam Brett Park, and the Notch. The trail would include seating, bike repair stations, fishing and kayak access, wildlife and river viewing, and other recreational amenities along its length. It would also construct a maintenance facility with storage and office space on the City of Beacon Recycling and Transfer Station property.
