Notice of Intent to Prepare a Draft Generic Environmental Impact Statement

Lead Agency: New York State Office of Parks, Recreation and Historic Preservation, 625 Broadway, Albany, NY 12238

This notice is issued pursuant to Part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) of the Environmental Conservation Law. The NYS Office of Parks, Recreation and Historic Preservation (OPRHP) as Lead Agency has determined that the action described in this notice may have a significant adverse impact on the environment, and that a Draft Generic Environmental Impact Statement (DGEIS) will be prepared.

Title of Action: **Adoption and Implementation of a Statewide Greenways Plan/Generic Environmental Impact Statement (GEIS)**

SEQR Status: Type I Action under 6NYCRR Part 617, of the implementing regulations pertaining to Article 8 (State Environmental Quality Review) of the Environmental Conservation Law.

Location of Action: Statewide

Description of Action:

The New York State Office of Parks, Recreation & Historic Preservation (OPRHP) is preparing a plan for a comprehensive statewide system of non-motorized multi-use trails (Greenway Trails) as directed by legislation signed by Governor Cuomo in November 2019 (<https://legislation.nysenate.gov/pdf/bills/2019/A5035B>). This Statewide Greenways Plan will identify trail user types, address trail needs and trends, and discuss the benefits of trails. The creation of the draft plan will solicit input from a variety of state and local stakeholders as well as from the general public. The Plan will also compile a GIS inventory of existing and proposed non-motorized, shared-use trails across the state. The Plan will provide a vision, goals and recommendations that will guide future planning and development of Greenway Trails in the State.

The final Plan will guide decision-making, influence greenway development policy in state and local governments, and inform communities, organizations and individuals engaged in trail development and management.

Reasons Supporting this Determination:

OPRHP considers adoption and implementation of this Statewide Greenways Plan to be an action which may have significant impacts on the environment because the Plan will act as a guide for the development of greenway trails across New York State. The Plan will provide a

vision and goals and recommendations for greenway trails' development efforts statewide, including directives on the development, design, environmental considerations, education, management and maintenance. The Plan will identify priorities that will advance the statewide trails network including newly identified trail opportunities, greenway gaps and existing and potential railbanking agreements.

The final Plan will guide decision-making, influence greenway development policy in state and local governments, and inform communities, organizations and individuals engaged in trail development and management. The Plan is intended to help shape the scope, character, purpose and function of the State's greenway trail system.

New York State contains significant natural, cultural and scenic resources. The plan is focused on the state's existing and future greenway trails, and it has the potential for impacts to natural, cultural and scenic resources. OPRHP has compared the issues and impacts with the significance criteria listed in Part 617.7. The GEIS process will allow OPRHP to evaluate alternatives by assessing potential impacts to these resources and select the best plan for direction of greenway trails in the state.

Scoping:

Scoping of the DGEIS will be conducted. OPRHP has prepared a Draft Scoping Document. The Draft Scoping Document is available on the internet for viewing or downloading at:

OPRHP will hold two public webinars to provide information on the Draft Scoping Document and offer the public an opportunity to comment. **REVISED DATE:** The webinars will be on May 14, 2020, at 9:30 -10:30 am and at 2:30 – 3:30 pm (content will be the same). People wishing to attend a webinar should send an email to StatewideTrailsPlan@parks.ny.gov with their name, title and organization requesting registration for the webinar. A registration confirmation email will be sent. Three working days prior to the webinar they will receive login information. Deadline to register is May 10, 2020.

The public comment period has been extended. Written comments will be accepted until **May 31, 2020**. Following the written comment period, OPRHP will prepare and post a Final Scoping Document.
