2024-25 Hunting Permit

Chimney Bluffs State Park Self-Issue Hunting Permit

Please carry this permit with you at all times while hunting in the park.

Valid: 10/15/2024 - 2/28/2025

Permit Conditions:

- Hunters shall comply with all applicable sections of the Environmental Conservation Law; Parks Recreation and Historic Preservation Law and their implementing regulations and shall hunt in the manner prescribed by the Department of Environmental Conservation, except as modified by the dates, times and hunting styles specified in this permit. This permit confers only those rights indicated herein.
- This permit is valid only for the period for which it is issued, shall not be transferred, and may be revoked at any time.
- Hunting is prohibited in the park outside of the dates indicated above.
- Within the dates indicated above, NYSDEC season dates per species apply furthermore.
- Big game, turkey, small game, waterfowl, and migratory game hunting is permitted during their respective NYSDEC seasons within the dates indicated above.
- Trapping is prohibited.
- Permitted hours for all activities conducted in the Park are from dawn until dusk. Entering the Park at night is prohibited.
- Hunting implements permitted per species are those prescribed by NYSDEC Regulation, EXCEPT FOR:
 - **RIFLES AND HANDGUNS ARE PROHIBITED AT ALL TIMES ON STATE PARK PROPERTY REGARDLESS OF SPECIES OR SEASON.**
- Hunters must carry this permit, hunting license and photo I.D. while hunting or scouting in the Park and produce them on request to any law enforcement officer or park employee. Any unauthorized alteration will void your permit.
- No person shall hunt in an area of a park that is posted or otherwise identified as a “Restricted/Prohibited Area.”
- Cutting, placing nails or screws into, or otherwise damaging trees or other vegetation is prohibited.
- All portable tree stands must have the owner’s name, address, and phone number. Permanent tree stands and blinds are prohibited. Screw in foot-pegs are prohibited.
- Any tree stands left in the park after the applicable hunting season are subject to confiscation and disposal by park personnel.
- Target and promiscuous shooting are prohibited.
- ATV’s and UTV’s are prohibited.
- Dogs must be leashed at all times.

Certification: I have read and understand the terms of this permit and agree to comply accordingly. It is my responsibility to read, understand and obey all NYS Office of Parks Recreation and Historic Preservation regulations and NYS Department of Environmental Conservation regulations.

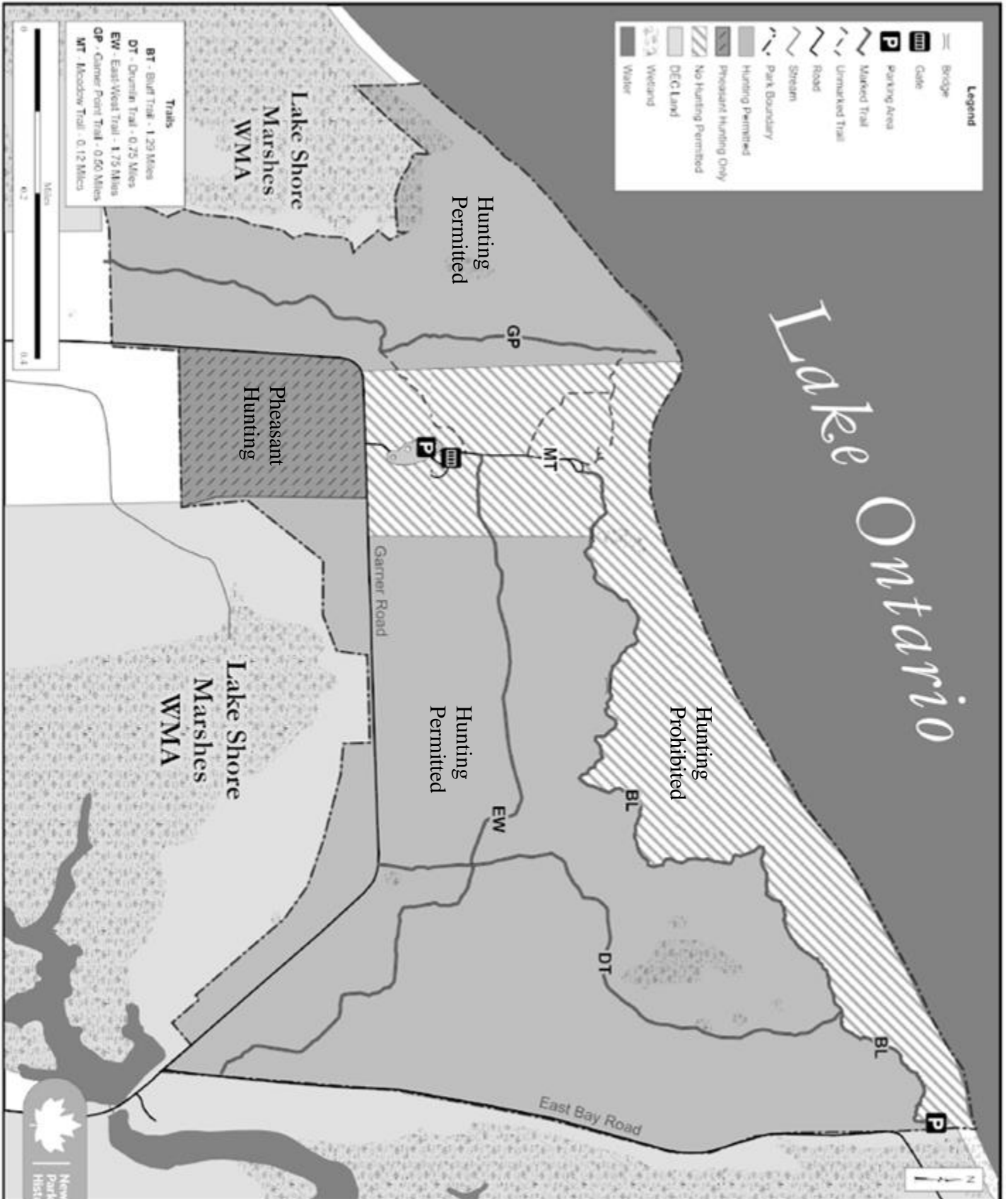
