**Hunting Pass** 

This portion of the permit must be displayed on the dashboard of your vehicle while hunting in the park.



## **Permit Conditions:**

This permit is valid only for the period for which it is issued, shall not be transferred, and may be revoked at any time.

Hunters shall comply with all applicable sections of the Environmental Conservation Law; Parks, Recreation and Historic Preservation Law and their implementing regulations and shall hunt in the manner prescribed by the Department of Environmental Conservation, except as modified by the dates, times and hunting styles specified in this permit. This permit confers only those rights indicated herein.

Hunters must carry their permit while hunting in the Park and produce it on request to any law enforcement officer or park official. Any unauthorized alteration will void your permit.

This permit is valid only in the hunting areas indicated on the attached map.

No person shall hunt in an area of a park that is posted or otherwise identified as a "Restricted Area."

Cutting, placing nails or screws into, or otherwise damaging trees or other vegetation is prohibited.

Target shooting is prohibited

Park lands are within WMU 8G

Motorized vehicles are prohibited.

Trained dogs or dogs in training are allowed to be off leash EAST of Eleven Mile Creek while in the act of small game hunting or small game training, all DEC regulations apply.

At least 400 square inches of florescent orange/pink (similar to a vest, front and back) are mandatory if you are hunting with a firearm, turkey season is an exception.

Bow hunting is allowed on both East and West sides of Eleven Mile Creek but there will be no hunting in the campground, day use or disc golf area. Crossbows and firearms are only permitted East of Eleven Mile Creek.

Permanent tree stands are not allowed. Portable tree stands are allowed but must not damage the trees and must be removed by January 6th, 2024

Hunters with valid hunting permits will be allowed to register to camp in the campground from 09/9/2023 through 10/9/2023. Hunting implements must remain locked in a vehicle while in the campground. Access to hunting areas must be from outside the park. Deer that are harvested are not allowed to be kept in the campground.
