TERMS AND CONDITIONS

- This permit is valid only for the period for which it is issued, shall not be transferred, and may be revoked at any time. Terms and conditions are subject to change.
- Hunters shall comply with all applicable sections of the Environmental Conservation Law, Parks Recreation and Historic Preservation Law and their implementing regulations and shall hunt in the manner prescribed by the Department of Environmental Conservation, except as modified by the dates, times and hunting styles specified in this permit.
- Hunters must carry their permit, hunting license and photo I.D. while hunting or scouting in the Park and produce them on request to any law enforcement, officer, or park employee. Any unauthorized alteration will void your permit.
- This permit is valid only in the hunting areas indicated on the attached map(s).
- No person shall hunt in an area of a park that is posted or otherwise identified as a "Safety Zone."
- Cutting, placing nails or screws into, or otherwise damaging trees or other vegetation is prohibited.
- Target shooting or indiscriminate/reckless shooting is prohibited and will result in immediate permit revocation.
- Park in designated areas only and display Parking Pass on the dashboard of your vehicle.
- Park open sunrise to sunset. Hunting hours will coincide with the hours set forth in the DEC Hunting Regulations. A reasonable amount of time will be considered to safely travel from your hunting location to your vehicle.
- No structures of any kind can be erected on property of OPRHP and no permanent stands are permitted. Lock-on or climber styles are acceptable and must be removed at the end of day. Tree stands cannot be attached by screws, nails, or other devices that will damage trees or other vegetation.
- Park lands are within Wildlife Management Unit 5J.
- Motorized vehicles are prohibited unless otherwise stated. Requests for usage of motorized vehicles for qualified people with disabilities may be submitted to park office for review.
- This is a multi-use area with various other activities taking place including but not limited to hiking, mountain biking, dog walking and horseback riding. Be sure of your target and use caution when near any trail.
- This is a Carry-In, Carry-Out facility. Personal equipment, including but not limited to spent shells and garbage, will be removed at the end of each day.
- Hunters with valid hunting permits will be allowed to register to camp in the campground during the camping season. Hunting implements must remain locked in a vehicle while in the campground. Access to hunting areas must be from outside the campground. Deer that are harvested are not allowed to be kept in the campground.
- Erecting, occupying or hunting from a permanent blind is prohibited.
- Trapping is prohibited.
- Hunting is not permitted within 500 feet of any building, road, playground, or parking lot, and all trails are considered safety zones where hunting is not allowed.
