# DENNY FARRELL RIVERBANK STATE PARK

## Skating Rink Rules and Regulations

1. Skate at your own risk.
2. Refund or re-admission is not allowed.
3. Keep your admission slip at all times.
4. All personal belongings must be stored in a locker. Riverbank is not responsible for lost or stolen items.
5. A \$6.00 fee is required for lost locker keys.
6. Make sure that your skates are properly secured before entering the rink floor.
7. Socks required of all patrons who wish to rent skates.
8. Protective skating gears such as safety wrist, knee, and elbow pads are recommended.
9. Safety helmet is a must for all 11years old and under. Helmets are available at the rink free of charge.
10. Proper attire is required.
11. Skaters are required to skate in one direction.
12. Skaters are not allowed in the bleachers or terrace with skates on.
13. The center of the rink is only for figure skating or lessons.
14. Spectators shall not interfere with Skaters
15. Ball playing in the building is prohibited.
16. Group counselors must always monitor their participants.
17. Excessive speed, cross cutting, bumping, and or reckless skating will not be tolerated.
18. Patrons with cast, slings, crutches, or recuperating devices are not permitted on the skating rink floor.
19. Food and beverages are to be consumed in designated areas.
20. Food and beverages not purchased at the rink concession is forbidden.
21. Eating drinking, carry/all, loose items, audio, or video devices are not permitted on the skate floor.
22. Smoking or alcoholic beverages are not allowed.
23. Wheel devices such as Bicycles, strollers, shopping carts are not allowed.
24. Audiovisual devices must obtain manager's permission to film at the rink.
25. Skaters and non-skaters must adhere to building evacuation as well as rules conveyed by skating rink personnel.
26. Patrons that are not wearing skates will not be allowed on the skating surface for any reasons.
27. Riverbank State Park reserves the right to cancel or reschedule skate sessions when necessary.
