Hunting Rules and Regulations Sampson State Park



Hunting is Permitted in Designated Areas ONLY! Park boundaries, restricted areas, and adjoining lands are posted to insure the safety of other park patrons, park personnel, and our neighbors. Waterfowl hunting areas are located in restricted areas where hunting is normally prohibited. When moving through these areas your weapon must be unloaded and cased. Failure to do so renders your hunting permit null and void.

Registration

- ALL HUNTERS MUST REGISTER **DAILY** AT THE PARK OFFICE.
- A separate waterfowl hunting permit will be issued for that day
- You are to have a park permit and a valid New York State hunting license, HIP registration, and Duck Stamp in your possession at ALL times.
- The permit must be returned to the park office before leaving the park
- You are required to report ALL game taken on the permit

Waterfowl Hunting Areas

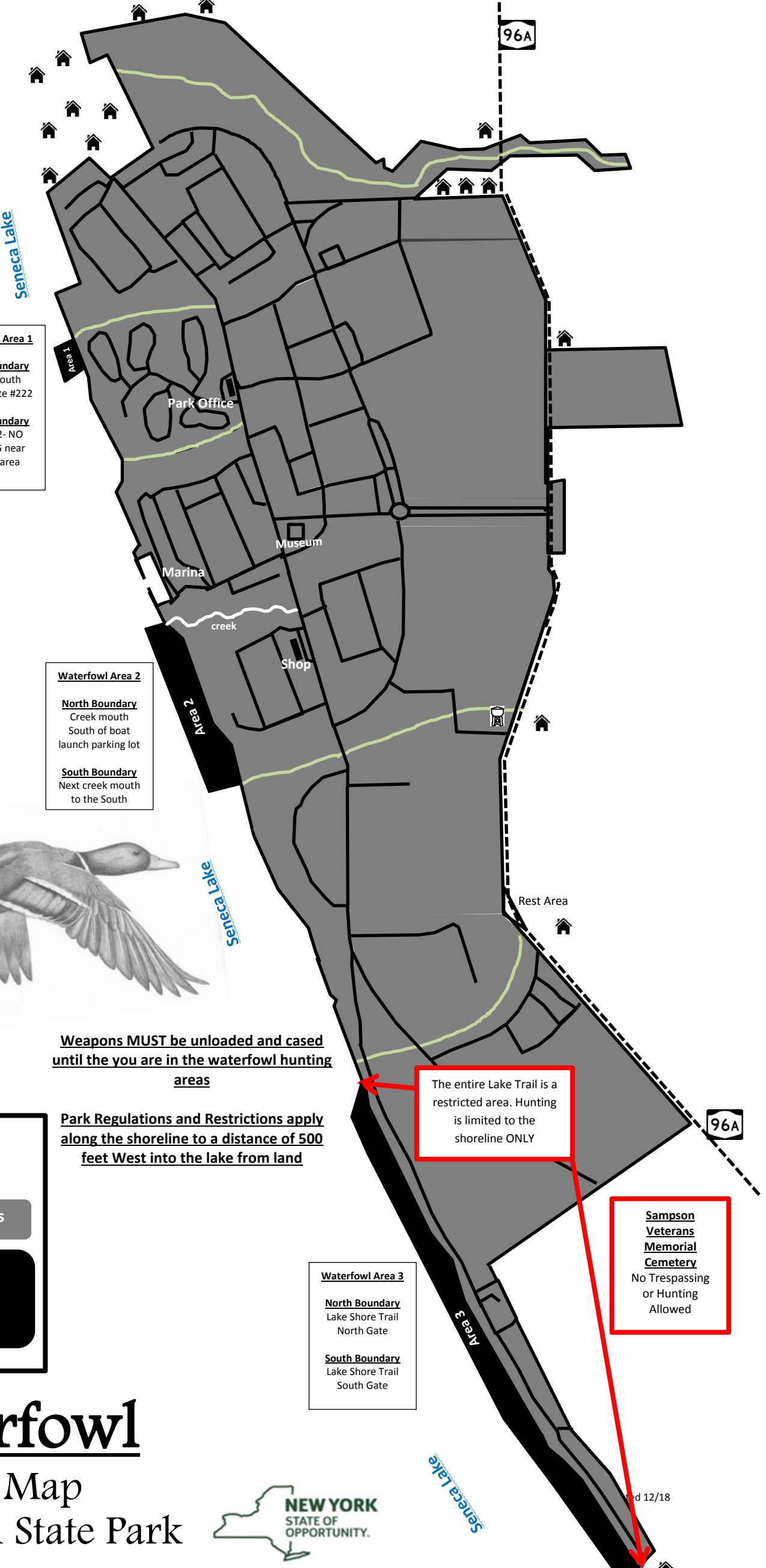
- See Map for waterfowl hunting areas
- Waterfowlers using boats may set decoys and retrieve wounded fowl. Hunters using boats must be in the designated areas with a permit or more than 500 feet from shore. NO hunting allowed from a boat within 500' from shore
- Hunters launching a boat from the park must have their weapons unloaded and cased until they reach shore in designated areas or more than 500 feet from shore
- All shooting must be over water and your muzzle direction may not break the plane of the shoreline
- Do not shoot in any other direction, as there may be other hunters, other park users, or park staff present.
 - Violators will be prosecuted and their hunting privileges will be revoked
- If a wounded bird enters a restricted area, the hunter may retrieve it
 - Entry with a loaded weapon is strictly prohibited

General Waterfowl Hunting Rules and Regulations

- Waterfowl hunting is permitted one-half hour before sunrise to sunset ONLY
- All shotguns equipped with a magazine must have the waterfowl plug inserted; limiting the weapon to a maximum of 3 rounds
- No person shall injure, destroy, deface, tamper with, or cut any park or personal property, trees, or other plant life.
- Blinds
 - No permanent blinds shall be constructed
 - Blinds may not be placed to "hold" a spot
- All sections of the New York State Environmental Conservation Law and New York State Park Rules & Regulations will be strictly enforced

The entire Lake Trail is a restricted area. Hunting is limited to the shoreline ONLY

Weapons MUST be unloaded and cased until the you are in the waterfowl hunting areas

Park Regulations and Restrictions apply along the shoreline to a distance of 500 feet West into the lake from land
