<sup>4</sup>Furbearer includes bobcat, weasel, opossum, raccoon, skunk, fox, mink, muskrat, and coyote hunting (hunting only, trapping is prohibited)

<sup>5</sup>Small Game includes cottontail rabbit, varying hare, squirrel, pheasant, ruffed grouse and bobwhite quail hunting. Reptile and Amphibian hunting is prohibited.

## **Permit Conditions:**

- This permit is valid only for the period for which it is issued, shall not be transferred, and may be revoked at any time.
- Hunters shall comply with all applicable sections of the Environmental Conservation Law; Parks Recreation and Historic Preservation Law and their implementing regulations and shall hunt in the manner prescribed by the Department of Environmental Conservation, except as modified by the dates, times and hunting styles specified in this permit. This permit confers only those rights indicated herein.
- Hunters must carry their permit, hunting license and photo I.D. while hunting or scouting in the Park and produce them on request to any law enforcement officer or park employee. Any unauthorized alteration will void your permit.
- This permit is valid only in the hunting areas indicated on the attached map.
- No person shall hunt in an area of a park that is posted or otherwise identified as a "Restricted Area."
- Cutting, placing nails or screws into, or otherwise damaging trees or other vegetation is prohibited.
- Target and promiscuous shooting is prohibited
- Archery only during the regular gun season within Southern Zone (2023 Season 11-18-23 to 12-10-23). To harvest a doe, hunters will need Deer management Permit for WMU 7A.
- There will be NO EARLY OR LATE SEASON HUNTING.
- Hunters must park in the designated parking areas. No roadside parking.
- Standard DEC rules and regulations apply for hunting on state land.
- No CROSSBOWS ALLOWED.
- Portable tree stands are permitted, provided they do not damage trees, from November 1<sup>st</sup> through the end of the regular southern zone season. Building or using a permanent tree stand is prohibited and may result in revocation of hunting privileges and restitution for damages. All tree stands must be out of the park after the last day of legal hunting at Selkirk Shores State Park. Park is not liable for any stolen or damaged stands.
- Vehicles are not permitted on any trails or interior roads unless specifically designed by written permission from the Park. Special access privileges will be considered for non-ambulatory hunters. Requests must be received in writing at least 30 days in advance.
