Instructions for obtaining a Hunting Permit via email:

- Please fill out the application to include your full name, address, telephone number, email address and emergency contact info (name & phone #).
- Sign the application at the bottom and date. (If applicant is under 18, please sign and have a parent or guardian sign as well)
- Email a copy of the completed form along with a copy of both your hunting license and driver license to the following email address: WestcottBeachSP@parks.ny.gov (a school or other photo id is acceptable for those under 18 without a driver permit, driver license or state issued ID)
- Once the required paperwork is received, your permit will be processed and emailed back to you. When you receive the email, please print all four pages. The first three pages are informational with permit conditions to be read and followed. The fourth page is your actual permit, which will need to be signed in the top and bottom half. The top portion should be kept on your person while hunting, and the bottom portion should be displayed on your vehicles dash.
- This application/permit will be valid for Southwick Beach State Park and Robert G. Wehle State Park during the specified dates on the application. This permit process will need to be completed every year.
- Please see the attached maps for the permitted hunting areas for both these parks.
