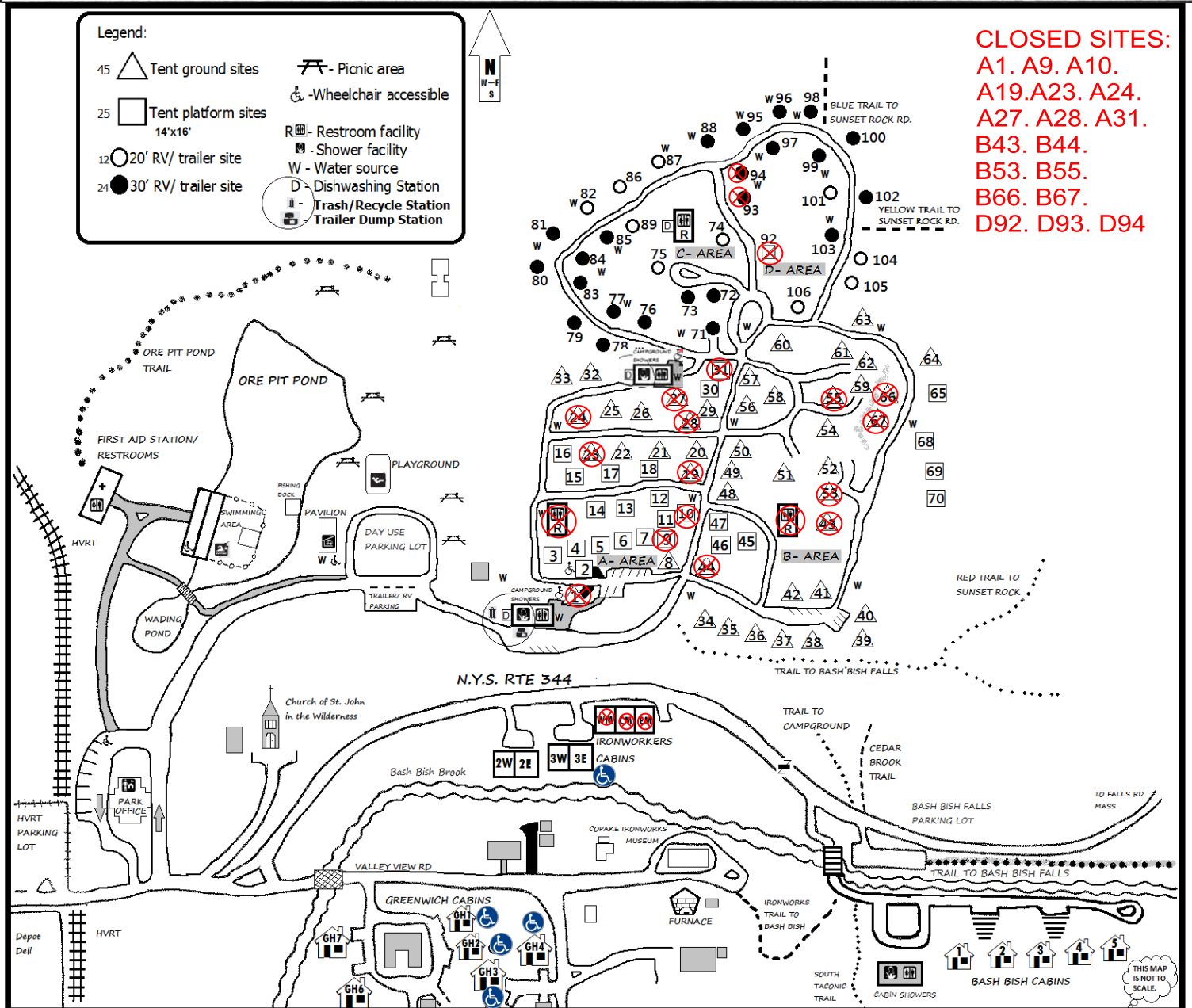


## ~Welcome to Taconic State Park Copake Falls~

As you select your site, please be mindful of the following:

1. **Before you set up on any site, you MUST have a camping/ cabin permit issued by the park office.** Once you have selected a site, please return to the park office to obtain your camping/ cabin permit by registering all people & vehicles staying on your site.  
Please keep the copy(s) of your camping/ cabin permit with the vehicle(s) registered on the permit.
2. Please note that the Shower house will be closed from 10:30am to 11:30am daily for cleaning purposes. Please plan ahead.
3. Garbage must be put in trash cans by each cabin area or brought to the garbage drop off area by the campground shower building.
4. We recycle paper & cardboard, glass, tin, plastic, aluminum, 5¢ refundable bottles & cans. Recycling stations are located at the garbage drop off area by the campground shower building & by each cabin area.
5. Your camping/ cabin permit and/or additional vehicle permits allow vehicle access to other New York State Park facilities for the period printed on the permit.



**Park Policies**

- Visitors shall respect the rights and privacy of others and shall maintain quiet hours at the campsite or cabin between 10pm and 8am daily.
- During the remaining portion of the day, all occupants and visitors will refrain from creating a disturbance or causing unreasonable noise that may disturb others.
- Operation of generators will be permitted only between the hours of 9am to 11am and 5pm to 9pm.
- Radios, stereos, and TV's must be kept at a reasonable volume so as not to disturb others and should be turned off during quiet hours.
- The Speed Limit within the Park and Campground is 10 MPH.
- Repeated car alarm activation is unacceptable.
- Dogs are not permitted in park buildings, swimming, or picnic areas. Where permitted they should be leashed, attended to, and cleaned up after at all times.
- Fires may be built and maintained only in designated fire rings/grills and fireplaces under the constant supervision of a responsible person. All fires must be extinguished prior to departure.
- Only wood from downed and dead trees shall be cut for fuel. Power saws are not permitted.
- Burning of trash is prohibited.
- Possession and use of fireworks is prohibited.
- Check out time for campsites and cabins is 11am on the day of departure.
- Occupancy of campsites is limited to 6 persons, including children. Cabin occupancy is limited to 4 or 6 persons depending upon unit.
- Campsites and cabins must be kept in neat, clean and sanitary condition. Washing at water fountains and spigots is not allowed.
- Camping is permitted only in park campgrounds. There is no trailside camping allowed.
- Nails and spikes are not to be driven into trees, platforms or buildings. All ropes must be removed.
- Do not move picnic tables, garbage cans or other park equipment without permission.
- Swimming is permitted only in designated areas when NY state lifeguards are on duty.
- Park trails are closed from sunset and sunrise.
- Patrons shall not deface, remove, damage, or destroy any park property. Do not harass or take any wildlife. Do not remove plants and minerals from the park.
- Permit holders and their guests will be held financially responsible for any damages to state property and may be subject to legal action.
- Violation of these rules may result in the cancellation of the camping/cabin permit with no refund.
