FINGER LAKES STATE PARK ANNOUNCES 2024-2025 HUNTING SCHEDULE

(October 2024, Trumansburg, NY...) Fred Bonn, Regional Director of the Finger Lakes State Parks, announced the 2024-2025 hunting schedule for the region's state parks.

For all hunting listed below, hunters must check with the park office to obtain a self-issue permit for any hunting and are responsible for referencing the New York Department of Environmental Conservation (D.E.C.) Hunting and Trapping Guide for the current dates and additional rules.

Allan H. Treman State Marine Park – No Hunting Allowed

Beechwood State Park – No Hunting Allowed

Black Diamond Trail – No Hunting Allowed

<u>Bonavista State Golf Course</u> - the following hunting is allowed:

- Deer, Archery
 - o Hunters must pre-register at the Sampson Park Office. They need to sign-in/sign-out daily and record their harvest at Bonavista.
 - Deer hunting will be by bow only and will be limited to one hunter per zone by first come, first serve basis (5 zones available). Hunters must sign in and out daily at the maintenance barn and indicate their zone. Harvests must be recorded. No reservations can be made. Contact Sampson State Park office for details.
- Turkey
 - o Fall turkey hunting is bow only.

<u>Buttermilk Falls State Park</u> - the following hunting is allowed:

- Deer, Archery
 - Hunters must sign in each day at the park office or upper contact station. Hunting is allowed in designated sections as indicated on the park hunting map at the sign-in station.
 - A separate special park permit is required for all hunters. Information on obtaining a permit is available at www.parks.ny.gov or posted outside of the park office.
- Deer. Cross Bow

 - A separate hunting permit may be obtained from the Seneca Arts & Culture Center the afternoon of the day prior to hunting.
 - o The permit indicates what area of the property may be hunted.
 - o No tree stands are permitted.

<u>Harriet Hollister Spencer State Recreation Area</u> – the following hunting is allowed:

- Deer, Archery
 - O Not open for the **September 14 22, 2024** antlerless season.
 - o The park DOES NOT participate in the Youth Firearms Season in October.
 - No hunting after the regular gun season concludes with any implements after <u>December 8</u>,
 2024.
 - o No hunting in the Reynolds Gull area.
- Deer, Cross Bow
 - O Not open for the **September 14 22, 2024** antlerless season.

 - o Fall turkey hunting is bow and cross bow only.

<u>Pinnacle State Park</u> – the following hunting is allowed:

- Deer, Archery

 - o No shotgun or rifle allowed.
 - o No muzzleloading during the Columbus Day Youth Season.
- Turkey

Robert H. Treman State Park – the following hunting is allowed:

- Deer, Archery
 - o At upper area of the park.
 - o Hunters must sign in each day at the park office or upper contact station.
 - Hunting is allowed in designated sections as indicated on the park hunting map at the sign-in station.
 - A separate special park permit is required for all hunters. Information on obtaining a permit is available at www.parks.ny.gov or posted outside of the park office.
- Deer, Cross Bow
 - o At upper area of the park.
 - o Hunters must sign in each day at the park office or upper contact station.
 - Hunting is allowed in designated sections as indicated on the park hunting map at the sign-in station.

<u>Sampson State Park</u> – the following hunting is allowed:

- Deer, Archery
 - o A separate special park permit is required for all hunting.
 - Hunters must register at the park office prior to hunting, check out in person, and report their harvest. Contact the park office for details.
- Deer, Shotgun and Muzzleloading Rifle
 - o No gun hunting during Columbus Day Youth Season
 - o A separate special park permit is required for all hunting.
 - There is a five-day regular shotgun season hunt by lottery draw. Contact the park office for details.
 - o Blaze orange hat or vest is required.
 - o Rifles are NOT allowed in or on any State Park property with the exception of muzzleloading rifles in designated areas during the designated season.
- Duck, Late Season
 - o Hunting is late season only.
 - o A separate special park permit is required for all hunting.

- o All hunters must sign in and out at the park office.
- o All harvests must be recorded.
- Turkey
 - o A separate special park permit is required for all hunting.
 - o Spring turkey hunting is zone specific for gun and bow.
 - o Zone reservations begin **April 1, 2025**. Contact the park office for details.

 - o All hunters must be in boats at all times.

Watkins Glen State Park – the following hunting is allowed:

- Deer, Archery
 - o Bow hunting on the west side of the railroad is open during DEC regulated archery seasons.
 - The park does participate in the Youth Firearms Season in October. Check the DEC website for dates.
 - o The east side of the railroad opens November 1 through the end of the DEC regulated seasons.
- Deer, Cross Bow
 - o Bow hunting on the west side of the railroad is open during DEC regulated archery seasons.
 - The park does participate in the Youth Firearms Season in October. Check the DEC website for dates.
 - o The east side of the railroad opens November 1 through the end of the DEC regulated seasons.
- Turkey
 - Spring turkey season only
 - Hunting allowed in the western portion of the park.

Other Park Rules and Regulations that apply:

- All portable tree stands must have the owner's name, address, and phone number. They must be removed at the end of the season unless otherwise noted above.
- Safety zones and restricted areas are posted to ensure the safety of other park patrons and regional personnel. Signs will be posted at all parks during hunting season to notify patrons of this activity.
- Handguns are not permitted in any State Park.
- No trapping is allowed at any of the State Parks in the Finger Lakes Region.
- A valid New York State hunting license with the proper hunting credentials must be carried with all hunters at all times.
