**HUNTING PERMITS ISSUED TO THE FIRST 500 APPLICANTS FOR THE ENTIRE  
DEER HUNTING SEASON.**

Hunting Area – West of the Genesee River

1. West of the Main Park Road: North from Castile Entrance Road to Gibsonville road at the top of Gibsonville Hill.
  2. East of the Main Park Road: North from Castile Entrance Road to old Schenck Road as it goes from Highbanks Camping Contact station southeast to the Genesee River (this area will be posted). North from Silver Lake outlet to the Hogsback Overlook parking area.
- EXCLUDED are the posted safety zones around Camping Area, Cabin Area C and Caretakers Residence.

Hunting Area – EAST of the Genesee River. The eastern side of the park east of the Genesee River as far North as the Visitor Center Road, EXCLUDING the Parade Grounds and Cabin Area D which are south of Trail 7 and west of the park road; also EXCLUDING the park land south of Route 436 which is NOT in Wildlife Management Unit 8M.

**NO RIFLE HUNTING ALLOWED IN LETCWORTH STATE PARK  
NO BEAR HUNTING ALLOWED**

**Legal Implements include Bow, Crossbow, Shotgun, Pistol and Muzzleloader in  
accordance with DEC regulations unless otherwise specified in Park Permits.**

\*\*\* THERE WILL BE A SECOND CHANCE FOR SHOTGUN (200 West and 300 East) FOR THOSE WHO DID NOT RECEIVE A PERMIT. THE SECOND CHANCE PERMITS WILL ALLOW HUNTING FROM 11/28 – 12/11 ONLY. SEE BACK FOR DETAILS.

**- ALL HUNTING REQUESTS AND PERMITS WILL BE ISSUED BY MAIL ONLY –  
NO PERMITS WILL BE ISSUED IN PERSON**

- Gates open daily until October 17, 2016.
- Hunting in Letchworth & Silver Lake State Park is by permit only.
- Letchworth State Park is Wildlife Management Unit 8M.
- Vehicles are allowed on public roadways only. Off road operation is prohibited. Park within one vehicle width off the road if parking on the lawn. **In the event of snow, park roads may be closed.**
- NO permanent tree stands are permitted. Temporary tree stands are allowed **1 week** prior to season but must not damage trees and must be removed by dusk December 18, 2016. If found after this date they will be removed and destroyed.
- Be aware, there are many visitors in the park who may be hiking, biking or snowmobiling in designated areas. Please look out for their safety as well as your own at all times.
- 400 square inches of florescent orange is mandatory during shotgun season (equivalent to a vest, front and back).
- Be absolutely sure of your target & beyond.
- Consider ALL firearms loaded.
- Hunters may enter the park at 5 a.m. and hunt from Sunrise to Sunset ONLY.

There have been confirmed incidents in Livingston County of Rabies in deer. Take adequate precautions to avoid direct contact with fluids and raw meat.

CABIN RENTERS: The first six people registered will receive their West and East side shotgun hunting permits upon registration to your cabin. Renters must occupy the cabin for the entire reservation period. Permits are not valid until 3 pm on check-in date.

PERMIT MUST BE CARRIED ON PERSON AT ALL TIMES.

REPORT violations to the NYS Park Police at (658-4692). Dial 911 for emergencies. ANY DEC OR REGIONAL VIOLATION MAY RESULT IN YOUR PERMIT BEING REVOKED AND/OR YOUR ARREST.

**TO APPLY FOR ALL HUNTING PERMITS**

All requests are by MAIL ONLY, no applications accepted or permits issued in person except to cabin renters.

**WEST AND EAST SHOTGUN APPLICATIONS.** Requests for the first 500 permits will start with applications postmarked 9/7/16 and will be issued as they are received in the mail. You may apply on the same application for up to 4 people. If any name appears on more than one application for the West or East Shotgun application, it will be considered stuffing and ALL permits will be void.

For WEST AND EAST applications please number in order of preference the side you wish to hunt. The first 500 applications will be issued permits for both the East and West side. If applying for more than one person for the shotgun lottery, please address your envelope as shown below.

\*\*\*Those who do not receive a hunting permit in the first round will receive a second chance to hunt from 11/28 - 12/11. These will also be issued as they are received in the mail and will be limited to 200 for the West side and 300 for the East side and are valid for hunting between 11/28 - 12/11 ONLY.
