- 50 DMAPs will be available; must be picked up at Visitor's Center and returned at the end of the day (office hours 8:30am - 4:00pm)
- **To better manage Big Game populations, ALL hunters are required to return a completed survey as a condition of your permit. Failure to return survey may result in you not being eligible to receive a permit next year.**
- Respect adjacent landowners and other park users
- All DEC and OPRHP hunting regulations apply

This previously closed area will be opened in an effort to help address the biodiversity losses in this section of the park. Your participation in this special season will help us gain a better understanding of deer populations and health within the park. Requirements for participation are as follows:

- Archery Only
- Antlerless deer may only be taken
- Complete and return mandatory survey
- You may use your own DMPs if you have them
- Park has available extra DMAP permits for this area. These will be issued on an as needed basis and only 2 DMP permits per hunter will be issued.
- No permanent stands
- Scouting allowed
- One name per application. ONLY 1 Application per envelope. Mail to: Special Zone Archery One Letchworth State Park, Castile, NY 14427. All information must be provided and a LARGE SELF-ADDRESSED STAMPED ENVELOPE MUST BE INCLUDED.

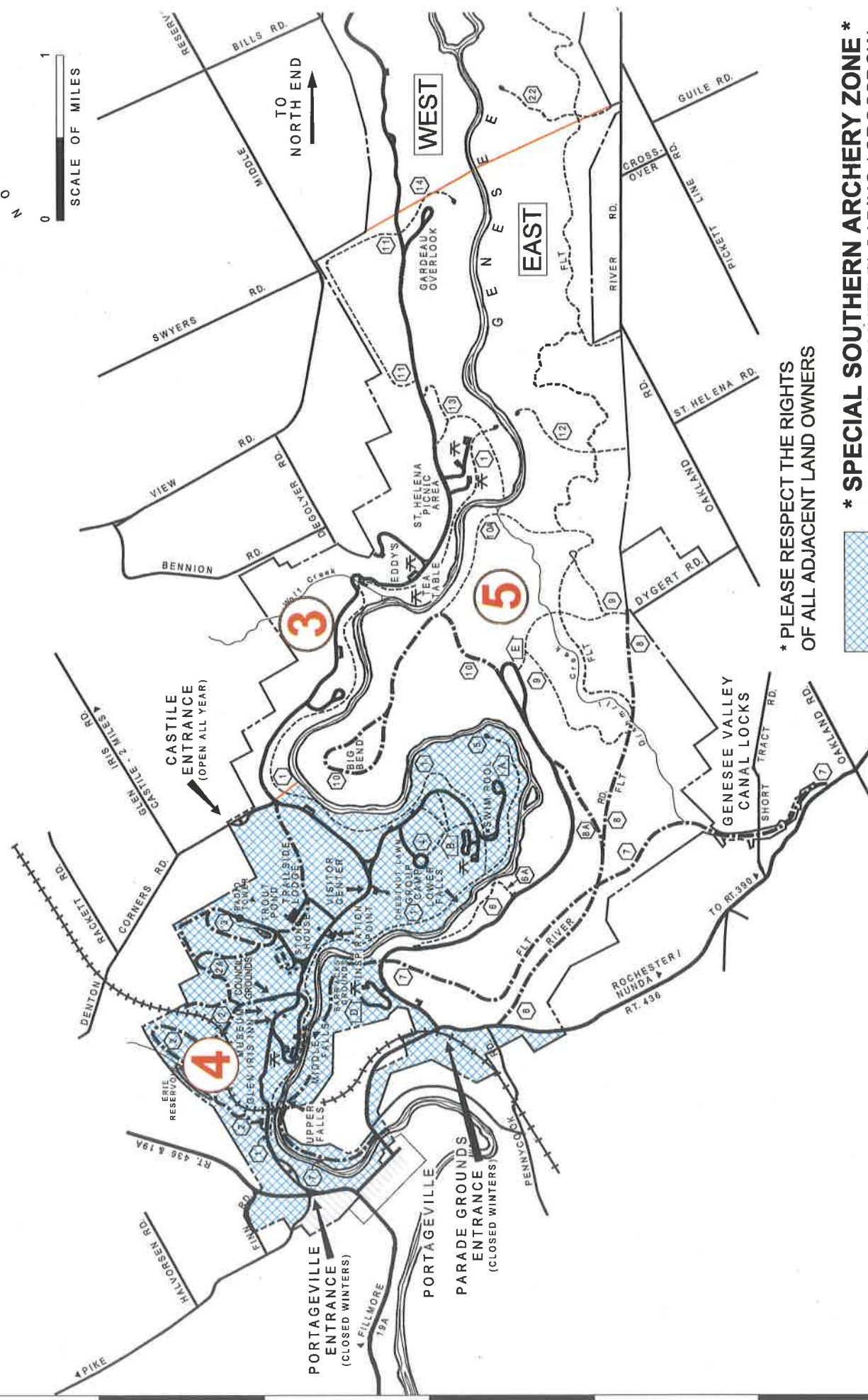
