### Permit Conditions:

- This permit is valid only for the period for which it is issued, shall not be transferred, and may be revoked at any time.
- Hunters shall comply with all applicable sections of the Environmental Conservation Law; Parks Recreation and Historic Preservation Law and their implementing regulations and shall hunt in the manner prescribed by the Department of Environmental Conservation, except as modified by the dates, times and hunting styles specified in this permit. This permit confers only those rights indicated herein.
- Hunters must carry their permit, hunting license and photo I.D. while hunting or scouting in the Park and produce them on request to any law enforcement officer or park employee. Any unauthorized alteration will void your permit.
- This permit is valid only in the hunting areas indicated on the attached maps.
- No person shall hunt in an area of a park that is posted or otherwise identified as a "Restricted Area."
- Cutting, placing nails or screws into, or otherwise damaging trees or other vegetation is prohibited.
- Target and promiscuous shooting are prohibited
- Parking is allowed in designated areas. Vehicles blocking gates/another vehicle will be towed at the owner's expense.
- **DEER HUNTING ONLY on all Minnewaska lands. SMALL GAME, BIRD AND BEAR HUNTING ARE NOT PERMITTED.**
- Discharging of any firearm within 200ft of any road, carriage road or trail is not permitted.
- Discharging of any firearm across any road, carriage road or trail is not permitted.
- **Hunters must report any deer hunting success. To report your deer hunting success call the Minnewaska Office at 845-255-0752.**
- Entry upon any private land adjacent to the park preserve shall be by permission of the landowner. It is the hunter's responsibility to know the Park Preserve boundaries.
- Vehicles not permitted on any trails/interior roads unless specifically designated by a sign or by written permission from the Park Preserve Manager. ATV's are prohibited in all New York State Parks at all times.
- No person under the influence of alcohol/drugs shall hunt in the Park Preserve & no person may carry/possess alcohol or drugs in the Park Preserve.
- Camping and fires are prohibited
- Please remove spent cartridges.
- Littering is prohibited. Use only biodegradable paper tape to mark blood trails etc. and collect it after use. Plastic ribbon lasts a long time and degrades the natural beauty of the forest.
- **Portable tree-stands are permitted provided they don't damage trees. Building or using a "permanent" tree stand is prohibited & may result in revocation of hunting privileges and/or restitution for damages. No screw-in steps permitted. All tree stands must be removed by 12/31/2019 or they will be confiscated, and tickets/fines will be issued.**
- The Park Preserve may be closed to hunting during periods of severe forest fire danger. Area newspapers & radio stations will be notified & signs will be placed at major access points. Call (845) 255-0752 or (845) 647-7989 for current information.
